



Clearance certificate

for conversion of the handlebar / stem combination with a 31,8 mm clamping diameter

Wilhelm Humpert GmbH & Co. KG hereby confirms that for the bicycle categories listed below it has no reservations about the use of the following handlebar/stem combination with "Safety Level 6".

- **Single- and multi-track transportation- and cargo bikes** with motorised pedal assistance up to a **speed of 25 km/h** and a maximum **permissible total weight of 300 kg**

The combinations have been sufficiently tested and meet the requirements of the "DIN 79010:2020" standard. A risk analysis has also been carried out. No hazard is therefore to be expected in connection with use on a bicycle in its original condition. However, the prerequisite for this is that the length of the brake and gear cables and/or lines has not been changed and that the bicycle remains in the prescribed condition.
